In consideration of the mutual covenants set forth in this contract, it is agreed as follows:

1. Quantity: Simply Green agrees to sell and deliver to customer, and customer agrees to purchase and receive from Simply Green _____ gallons of BioHeat® (#2 heating oil with a blend of Biofuel, called BioHeat®. Fuel meets all ASTM specs). 500 gallon min.

2. Gallons _____ x "calculated price" = \$ _____ sub-total (A)

If daily price of BioHeat® goes below "calculated price", during delivery contract term, Customer will receive lower price.

3. **Payments:** At the 1st of each month, customer agrees to pay to Simply Green the total of (B), if there is not credit on account or (C) if there is a credit on file \$ _____ every month starting June 1, 2010 and ending March 1, 2011 (paid by cash, check, money order or credit card – Visa, M/C or Discover). For prior season credits, "dollar figure" credit will stay on account and monthly budget payment will be adjusted (contact office after May 31, 2010). Simply Green reserves the right to adjust the monthly payment to a lower amount if fuel prices go down and credit exceeds the expected use for the season. **Credit card will be charged if payment is not received by the 15th of the month plus a \$25 late fee.** If account is past 30 days, Simply Green will send out a final collection letter. At that time, if no payment is received, the account will be sent to small claims court and an \$85 filing fee and all applicable fees moving forward will be added to the account.

4. **Term:** Breathe Easy budget delivery will begin October 1, 2010 and end May 31, 2011. During this term, customer will be placed on Simply Green's Automatic Delivery program ensuring fuel delivery will be set by Simply Green's internal tracking software. At the end of the predetermined term, any unused gallons, which were part of the plan, shall be treated as follows:

- a. If customer stays on Simply Green's Automatic Delivery program, and has not changed to another oil company, then the unused dollar value of the oil will stay on as a credit and be used toward the following year's pre-buy program or used up in the off season and charged to account based on the daily rate. If customer does not stay with Simply Green, then at no time will a cash or credit refund be available on unused gallons, unless the value is \$100 or less.
- b. After May 31, 2011, customer remains on automatic delivery at the daily rate until new lock-in program is established by customer signing a new contract, or until cancellation of fuel service.
- c. Buy-out option – a \$250 processing fee will be assessed if customer opts to cancel contract prior to contract end date.
- d. For any Automatic Delivery customers that call for a delivery prior to their scheduled delivery and receive less than 150 gallons, a \$0.10 per gallon delivery fee will be added to the invoice.
- e. All customers must be topped off by Simply Green when contract is signed at daily price and gallons are not accounted for in above mentioned pre-buy gallons.
- f. Last delivery of season, on or around May 31, 2011, regardless of credit amount, must be a "fill".
- g. Simply Green meets the NH Attorney General requirements for "Petroleum Sales Contracts" under HB903, section IV(a).
- h. Credit card charges, checks and payments will be placed into a separate escrow account for the customer's protection and will not be used until the contract gallons are delivered during predetermined term.

5. Miscellaneous:

- a. Force Majeure: Simply Green shall not be required to deliver oil during any period in which their operations are interrupted by labor disputes, fire, flood, washouts, breakage of tanks or pipelines, the act of any governmental or military authority, inevitable cause, or any other cause whatsoever beyond Simply Green's control, but delivery shall commence immediately upon cessation of such interruption.
- b. Customer Equipment: Customer will keep its fuel tanks, lines and other equipment, including vent whistles, fill pipes and gauges, in good condition at all times. Simply Green is not liable for any damage or loss that may occur or any breakage or accident to lines or equipment due to causes beyond Simply Green's control.
- c. Assignment: A transfer of or succession to the interests of customer under this contract, wholly or partially, shall not affect or bind Simply Green until Simply Green has been furnished at its office at 909 Islington Street, Portsmouth, NH 03801, with original instrument or with proper proof that the assignee is legally entitled. Any assignment is invalid unless the assignee agrees to the terms herein.
- d. Taxes: In the event of any heating oil tax or environmental fee, enacted by state, federal, county or municipal agencies, the customer shall be liable for any gallons subject to the new tax or tax incentive.

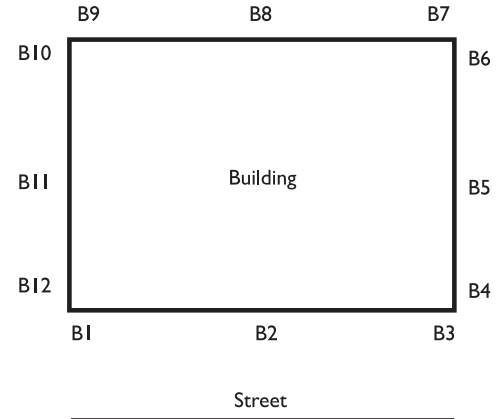
